Forty-seven participants in family group conferences and six professionals involved in the conferencing process or its preparation were interviewed. The article demonstrates that there is a significant gap between aspirations of proponents and practical realities of restorative justice. Possible explanations for the existence of the gap are suggested. It is argued that the findings of this study support some concerns of critics about dangers resulting from pursuing restorative ideals in practice</p>
